Prior to signing any training agreement, both parties should discuss expectations, training methods, goals and abilities of both the horse and rider.

Training will begin on _____ (date) and will be continued on a month to month basis until such time as it is agreed upon by both parties that the training be terminated. Advance warning of termination (at least 2 weeks) is appreciated and the Owner must have all past due amounts paid in full prior to the horse leaving Command Performance.

The agreed upon cost for training (including board) shall be \$_____ per month payable upon receipt of invoice if not earlier. Training fees and the first month's fee are due in advance. Any amount which is not paid within 10 days of the due date shall be subject to a \$40 late fee.

If the horse is to be shown:

The Trainer will engage in showing and retain the right to select shows where the horse shall be shown pending notification and approval of the Owner. The Owner will be responsible for the following costs incurred with showing: Entries, Stabling, Office and/or show administrative fees including association fees, Transportation, Handling & Preparation. In addition, the Trainer shall be entitled to 10% of any monies won, All other monies, trophies, prizes and ribbons shall belong to the Owner. The horse will be entered in the name of the Owner and handled in the name of the Trainer.

In the event the horse becomes ill or needs medical attention, the Trainer or representative shall care for the horse to the best of his/her knowledge and notify the Owner by telephone as soon as is practical after the problem is discovered. The Trainer or representative may, at his/her discretion, arrange for veterinary or alternative health care by a qualified practitioner. The Owner agrees to pay all such expenses. Trainer may administer medication to Owner's horse and Owner waives all potential claims and agrees to indemnify and hold Trainer harmless if, as a result of Trainer's administration, Owner's horse dies or is injured.

Owner shall be responsible for payment to have his/her horse shod by a farrier of Trainer's choosing.

Owner acknowledges that he/she is hereby advised by Trainer to purchase and wear a well-fitted helmet, or similar protective head gear, properly fastened when riding and working around horses. Owner further acknowledges that he/she is hereby advised by Trainer to always wear hard soled, fully enclosed shoes or boots, socks and long pants while working around or riding horses. Trainer agrees to advise Owner on use of reasonable tack and equipment for his/her horse, but Owner bears responsibility for his/her ultimate choice of tack and equipment and the security of such items. Trainer shall not be liable for Owner's loss or damage of tack or equipment.

Owner agrees to release, discharge and hold Trainer harmless from any and all liability or causes of action arising from incidents which may result in bodily injury, death or property damage to Owner, Owner's guests, family members, tack or equipment.

Owner acknowledges that it is possible that injury may occur to Owner's horse within the context of training and exercise provided by Trainer or representative. Owner agrees to release and hold Trainer harmless from any damages arising out of injuries suffered to Owner's horse while said horse is under Trainer's care. Trainer shall not be liable for injuries or damages arising out of the boarding, feeding, transportation or care of Owner's horse. Owner agrees to hold Trainer harmless from all damages sustained by Trainer's facilities or property or damages suffered by persons due to actions of Owner or Owner's horse.

Trainer shall not be required to obtain liability insurance providing coverage for Owner, Owner's horse, Owner's equipment/tack while said are on Trainer's property. If Owner desires insurance, it shall be his/her responsibility to obtain it.
